Nathan Oxnam has been "in the trenches" during his sixteen years with Advanced Health Care (AHC), helping open several facilities and serving as a regional administrator before becoming the COO in 2016.

"I'm always deep into data and analytics—more especially when having to deal with payment and reimbursement changes," says Oxnam, "I spend a lot of time forecasting, so I have to have good data." He's found that MatrixCare's MyAnalytics gives him the flexibility to gather relevant data, create customized reports, and share key findings with leaders to make informed decisions.

Since its founding, AHC has shifted from what Oxnam calls the "traditional" long-term care space to a focus on short-term transitional care. Typically, "products that are meant for our industry don't align with the needs we have, so I often have to gather data to create my own reports."

He says, "MyAnalytics is a good option for me. I use it primarily to gather data and then create my own reports." Oxnam said he can gather data and paste it into spreadsheets that allow him to drill down differently than standard industry reports and having those unique insights is a competitive advantage. "We push data from MyAnalytics into templates that we have created to monitor key metrics. Our administrators and nursing teams use these metrics to help drive excellence."

#### Simplified access to data

A key benefit of MyAnalytics is the ability to pull data for multiple facilities all at once. "Before this product, I would have to pull reports one facility at a time," Oxnam says. "It was tedious and timeconsuming. Now I can pull a quick report and know everything in the report is current."

Oxnam notes that the switch to PDPM has led to an increased need for data. "Success in PDPM is really about capturing the full picture of the patient. It's complex, with multiple domains and clinical information being pulled from many different sources."

"For PDPM, we care about all the drivers of reimbursement. We want to make sure we're not missing any information about the patient that influences the daily rate," Oxnam says, "MyAnalytics helps our facilities capture a complete picture about each patient.

#### From "guessing" to forecasting

Having easier access to data has also improved his organization's revenue forecasting, Oxnam says. "The data was always there; it was just hard if not impossible to get," he explains. PDPM we had to forecast based on small samples and extrapolation. For more than a year, through RCS, then PDPM, we were forecasting where we thought we would land."

"Now, it's great to know where we stand with everything, whether it's good or bad. We just want facts. Important decisions are based on this information. We love that the information updates daily. The real time nature of the data is valuable across the organization from individual facilities to the corporate office."

#### Data applied to patient care

Oxnam says the data from MyAnalytics can also help with staffing. "Each of our facilities have budgeted benchmarks for labor to ensure they



are taking excellent care of patients. In one of the facilities, data from MyAnalytics allowed the facility to recognize unusually high patient acuity. They were able to quickly adjust staffing to better meet the needs of those complex patients. It was one of those we things we didn't anticipate learning from the data—but ultimately benefited the patients and staff at the facility."
