

User workflow

Task list/dashboard: This main landing page will display those assessments that are "Available for Review." Reviewers can filter this view to support their workflow and complete timely reviews, as well as quickly see Completion and Received Dates, Assessment Type, Clinician Name, Patient Name and MR Number, and Status.

Integrated review process: The scrubber results are integrated into the review process. The reviewer has multiple options to filter the review display screen to support their workflow, and has access to pertinent patient information to support them in making the most appropriate recommendations including:

- Financial impact: Users can view financial information based on clinician answers and re-calculate as the reviewer makes recommendations to see the impact to the agency's reimbursement.
- Additional functions toolbar: In the top right of the display screen, the user has access to additional functions to support and complete their review process.
- Alerts by severity: The user has the ability to filter and review alerts by severity or by clinical category.
- Areas of Impact: Areas of Impact are identified with icons for each alert to inform the reviewers how the alert impacts key areas for the agency.
- Completing a recommendation: When completing the review, the alert will be color-coded by severity and show the areas of impact in the header. The user will see the complete alert message and the clinician's original response. They can then enter a Recommendation Note.
- Medications/diagnoses: To ensure the reviewer is making recommendations based



on all pertinent patient data, the user will also be able to review any active medications or diagnoses entered for the patient.

• Day-to-day reporting: The Report tab helps the review team manage their day-to-day workflow and complete their reviews timely. There are multiple filters to quickly see status and progress. As reviews are completed, data is fed to our Analytics department for additional reporting.
